**PARTICIPATION AGREEMENT FOR ASCAP, BMI AND SESAC-- 2018  
(Weekly, Bi-Weekly or Monthly Parties/Dances)**

In order to effectively and efficiently enforce their rights under the copyright laws of the United States, American composers, lyricists, and publishers usually join one of the three performing rights organizations. They are: The American Society of Composers, Authors and Publishers (ASCAP), Broadcast Music, Inc. (BMI) and SESAC. The National FastDance Association (NFA) has negotiated and entered into Licensing Agreements with all three organizations since 1998. Qualified NFA affiliated members that host or sponsor weekly, bi-weekly or monthly parties for their members and guests can come under the umbrella of protection through our Licensing Agreements with these organizations. Included is the music played by deejays and bands. Acknowledging this, and wishing to comply with, and not infringe upon, National Copyright Laws we, the organizational leadership, wish to participate in the Licensing Agreements established between the NFA and ASCAP, BMI and SESAC.

We have designated the individual signing below to complete this form by providing the total number of annual parties and the estimated average number of people attending annually. Via email attachments, the NFA will provide its attractive logo as well as ASCAP, BMI and SESAC logos that we agree will appear on our club website, our newsletter if applicable, and all advertising/flyers/promotional materials for our dance activities. Please send this report and check to the NFA no later than thirty (30) days after receiving it. Your processing of this document and fees should be expedited because upon receipt of the Agreement and fees, the NFA will provide you a Participation Confirmation Certificate for your club files. This document can be shown to anyone who may inquire about your dance activities being properly licensed, so the sooner you receive the Confirmation, the better.
